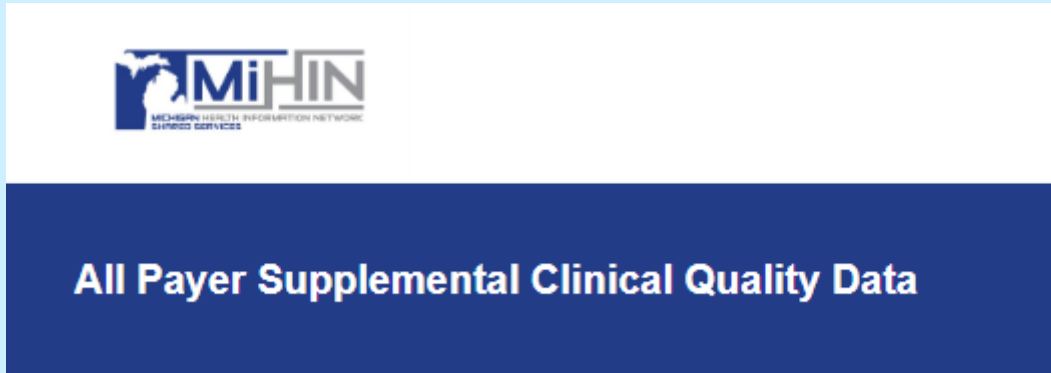

For ADT Reports:

Please make sure to pick up the Admit, Discharge, and Transfer Reports (ADTs) within **7 days** of posting. This is very important for transition of care and to get your patients the care necessary. Demonstration of using the reports is required for 2019 and will be required for 2020.

For Unmet Measures:

Please make sure to pick up the Unmet Measure Reports within **30 days** of posting. These gaps in care reports show the services needed for your patients on an All Payor basis. Demonstration of using the reports is required
